

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to spragueinstrument.com, associated sub-domains, and Sprague Instrument, Inc. and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Sprague Instrument, Inc. include spragueinstrument.com, and Sprague Instrument. The Sprague Instrument website is an E-commerce site. By using the Sprague Instrument website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Sprague Instrument may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address
- Phone Number

If you purchase Sprague Instrument's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through Sprague Instrument's public message boards, this information may be collected and used by others.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. Use of your Personal Information

Sharing Information with Third Parties

Sprague Instrument does not sell, rent or lease its customer lists to third parties.

Automatically Collected Information
